Privacy

The Kitsap Public Health District (KPHD) is committed to protecting the privacy of visitors to its website. KPHD only collects personal, identifiable information, including specific email addresses, from site visitors, when site visitors voluntarily and explicitly provide it. This information is collected when site visitors use KPHD email and respond to online surveys.

For visitors who wish to receive a response to an inquiry, information such as name and address will be required so KPHD staff can respond. That personal information will not be used for purposes other than to respond to the inquiry without permission.

KPHD collects data on website activity for the purpose of statistical analysis of site performance. Information such as a visitor's IP address, Internet service provider, date and time of visit, or the link that led to the KPHD site may be collected. Summaries of the results are available to KPHD staff and public, and contain no personally identifying information. KPHD may be required by law to disclose information in response to various public records and other requests from private individuals or governmental bodies. KPHD also shares server activity information with law enforcement officials when indications of criminal activity or intent to commit such activity are present.

KPHD staff may use information submitted by website users through email in carrying out their official duties and responsibilities and to respond to inquiries. There may be instances where complaints from visitor emails may be shared with those about whom the user is complaining, or to other governmental agencies involved in the administration and enforcement of the matter.

Email to KPHD, like all non-encrypted Internet email communications, may be accessed and viewed without visitors' knowledge or permission while in transit to KPHD. Email sent to KPHD should not be considered secure or confidential. Visitors who have confidential information to communicate may want to contact KPHD by telephone at the numbers provided for various locations on KPHD sites or by surface mail.
