# KITSAP PUBLIC HEALTH BOARD MEETING MINUTES Regular Meeting May 6, 2025

# **HEALTH OFFICER/ADMINISTRATOR'S REPORT**

# **Administrator Report:**

Yolanda Fong, Administrator, shared three updates:

- Last month, the Centers for Disease Control and Prevention (CDC) distributed notices to terminate multiple pandemic-related grants. Due to legal challenges, the funds are temporarily accessible. As a result, the Health District has reinstated some vaccine clinics, and information can be found on the Health District website.
- Funding for Foundational Public Health Services (FPHS) has been reduced by \$24
  million for the biennium. The impact to local health jurisdictions is not known yet.
  Washington State Association of Local Public Health Officials (WSALPHO) has begun
  communications with jurisdictions. FPHS funding constitutes 22% of the Health District's
  budget for 2025.

> • The Washington State Environmental Health Association's Annual Education Conference was held last week at the Suquamish Clearwater Resort. Ms. Fong and several Environmental Health staff attended. The conference included presentations and learning sessions on various environmental health topics, led by local and tribal public health practitioners from across the state. Health District staff were among the presenters. Anne Moen, Food and Living Environment Program Manager, served as the conference chair and led efforts to organize a successful event.

# **Health Officer Report:**

Dr. Gib Morrow, Health Officer, shared several updates:

- Legislative Changes The State Legislature passed several bills to strengthen public health:
  - HB 1531 Preserves public health officials' ability to use scientific research for addressing communicable disease.
  - SSB 5163 and HB 1459 Modernize the child fatality statute and emphasize coordination, aligning with national standards.
  - HB 1432 Improves access to mental health and substance use disorder services.
  - o SSB 5480 Removes barriers caused by medical debt.
  - o HB 1392 Establishes the Medicaid access program.
- Improving Healthcare Access in Kitsap Several initiatives are underway to improve healthcare access, including:
  - Kitsap Community Health Priorities (KCHP)
  - Board Resolution 2024-04 Declaring High Costs and Insufficient Access to Care Public Health Crises
  - o Johns Hopkins Center for Health Security assessment for Kitsap County
  - o Additional community assessments and strategic partnerships.
  - o Dr. Morrow provided a timeline of these initiatives from 2018 to 2025.
- Public Health in Regional Planning
  - Regional planning is being used to improve population health outcomes such as access to care, chronic disease, healthy environments, and social connection.
  - Public health is represented on boards and committees within the Puget Sound Regional Coordinating Council.
- State Department of Health (DOH) Radon Poster Contest
  - DOH holds an annual poster contest to raise awareness of radon risks among youth ages nine to 14.

#### **OLYMPIC CONNECT**

Miranda Burger, Olympic Community of Health Director of Programs, presented an overview of their new service, Olympic Connect. During the presentation, Ms. Burger shared information about:

- Olympic Community of Health's (OCH) objectives, service areas, and funding sources.
- OCH's Community Care Hub and the services they provide.
- Olympic Connect, a new program aiming to remove barriers to accessing care and services.
- The services provided by Olympic Connect and their network of partners.
- Key barriers the program addresses.
- Funding sources supporting the program.
- Client and partner journeys through the program.
- Examples of contracted care coordination partners and partners who focus on enhancing access to social care.
- Metrics used to evaluate success.
- Opportunities for those interested in partnering with Olympic Connect.

## COMMUNICABLE DISEASE SURVEILLANCE AND RESPONSE: AN OVERVIEW

Liz Davis, Immunizations and General Communicable Disease (GCD) Program Manager, and Wendy Inouye, Communicable Disease Epidemiologist, presented an overview of the Health District's communicable disease surveillance and response work:

- The process for surveillance and response to communicable diseases.
- Detection methods for potential cases.
- Steps taken to investigate cases.
- Communicable disease response strategies.
- Surveillance tools for monitoring and detecting public health issues.
- Translating data into evidence-based practices.

### ADDRESSING COMMUNICABLE HEALTH THREATS

Ms. Davis then provided updates on current health threats and the District's response:

- Tuberculosis (TB) data on evaluations, suspected and confirmed cases, and client management.
- Measles cases and outbreaks in the United States in 2025.
- Measles activity in Washington State and Kitsap County.
- Measles, mumps, and rubella (MMR) vaccine coverage in Kitsap between 2014 and 2023.
- MMR coverage by school district and strategies to improve vaccination rates.
- Health District's pertussis response from January through March of 2025 and pertussis activity elsewhere in the United States.
- Efforts to promote and support immunizations.
- Emphasis on the role of public health in supporting whole-community health.

Board members discussed the presentation and asked clarifying questions.
